EU B@B Platform's first Burean Meeting

The first EU Business and Biodiversity Platform Bureau Meeting took place in Brussels on July 8, 2014. Bureau Advisors - from business, Member States, NGOs and Commission Services - met and discussed the work carried out by the EU B@B Platform and its members. Discussion topics included: reviewing the results so far, identifying the most promising opportunities, links with relevant initiatives, upcoming events of mutual interest and next steps including brainstorming on the 2015 workstreams. Draft Natural Capital Accounting Decision Matrix

The NCA workstream developed a draft NCA decision matrix to help businesses decide what form of NCA is most suitable for them to undertake. The draft NCA decision matrix is currently being tested by different members and a second follow-up workshop will be organised in Brussels on the 22nd September, 2014 to discuss the draft decision matrix and share experiences.
